THE PROGRAM OF UPDATING AND MODERNIZATION OF THE FIXED ASSETS OF THE ENTERPRISE IS SUBJECT TO INCLUSION IN THE REGISTER OF PROGRAMS IN THE EVENT OF ITS COMPLIANCE WITH THE FOLLOWING REQUIREMENTS:

1

the program is implemented (planned to be implemented) by a legal entity registered in the Kaluga Region, whose enterprise is located in the Kaluga Region, or a branch of a legal entity located in the Kaluga Region, whose enterprise is located in the Kaluga Region;

2

the activities of the program must correspond to the types of economic activity specified in section C of the All-Russian Classifier of Types of Economic Activities OK 029-2014 (NACE Rev. 2);

3

the program must be drawn up for a period of 3 years and be an integral part of the program to increase the productivity of the enterprise, which establishes an increase in the indicators of increasing labor productivity at the enterprise annually by 5% during the term of the program;

4

the total volume of capital investments for the acquisition (creation), reconstruction, technical re-equipment, modernization and / or additional equipment of production within the framework of the production modernization program is at least 5 million rubles.

* 1) an application in the approved form;

2) a program for updating and upgrading the OS of the enterprise, approved by the head of the investor or a person authorized to act on behalf of the investor;

3) a productivity improvement program approved by the applicant's manager or a person authorized to act on behalf of the investor;

4) documents confirming the authority of the person who signed the official appeal and the program to modernize and increase production productivity;

5) copies of constituent documents with all changes and additions;

6) a copy of the certificate of state registration of the legal entity;

7) a copy of the certificate of registration with the tax authority;

8) information on the expected results of the organization's activities, including the achievement of growth in indicators of increasing labor productivity at the enterprise by 5% annually during the duration of the program.
